# **Course Objectives**

In this course we explore aspects of contemporary theory in archaeology arising from post-modernist critiques of recent archaeological practice. As noted, our approach will be exploratory in nature; we will examine new material, some of it controversial because it challenges not just the status quo but recent developments as well. Our goal is to develop and to refine our own perspectives on contemporary archaeological thought and practice through engaging in constructive critique of the readings.

# **Course Format and Requirements**

The class will be conducted in a seminar format; a portion of our weekly class meetings will be devoted to discussion of the week's readings. All students are expected to attend all classes and to participate in class discussion; to this end, a student will be designated as discussion leader for each session. Students must come to class having done all of the assigned reading and be prepared to discuss it.

All students enrolled in the course are expected to prepare a final paper of from 20–25 pages in length. Please note that *all paper topics must be approved by the instructor on or before February* 22, 2010. Papers are due no later than 5 p.m. on May 3, 2010. I will not accept late papers. There is also a final examination, cumulative in content, take-home in format. Grades for the course will be based upon the following: class attendance and participation & discussion: 30%; paper: 35%; final examination, 35%.
